If you make such a request, you are responsible for the fees and costs associated with furnishing you the documents specified in the request. The clerk may require a deposit to cover the estimated costs of furnishing you with the requested notice.*

*You are notified that, if you are a relative of the proposed ward as defined in Sec. 1051.103(a)(2) or (a)(4), and if a guardianship is created for the proposed ward, you must elect in writing in order to receive notice about the ward under Sec. 1151.056, Estates Code.*

The officer executing this citation shall post the copy of this citation at the COURTHOUSE door of the county in which this proceeding is pending, or at the place in or near said COURTHOUSE where public notices customarily are posted, for not less than 10 days before the return day thereof, exclusive of the date of posting and return the original copy of this citation to the clerk stating in a written return thereon the time when and the place where such copy was posted.
