AUCTION GUIDELINES

Expenses are high. You need a check for our items and we need the commission. If we do not get it sold no one gets any money.

Most items will sell but to protect your item, a reasonable minimum may be left. All target prices must be within fair market value and approved by auction staff.

1. All the first time buyers and consignors must furnish references and proper I.D.
2. All serial numbers will be recorded on tractors & titled vehicles.
3. Check in sheets must be signed by the owner or driver.
4. All items checked in must be clear of any liens or mortgages, and verified by signature above.
5. No items will be sold from lot 5 days prior to auction.
6. Absolutely no trading on auction yard will be tolerated!
7. ANY ITEM NOT SOLD WILL BE PLACED IN THE ABSOLUTE ROW AND SOLD ON THE 3RD AUCTION IN ORDER TO PREVENT A DECREASE PRICE EACH MONTH.
8. Buyers Responsibility: We are not responsible for prices received.
9. Commission Rates: 10% for the first \$2,000, 5% for everything over \$2,000. \$10 minimum commission per lot.
10. For all titled vehicles a non refundable consignment fee of \$50, a clear marketable title, and a signed application for transfer must be in office or there will be no sale. No exceptions. Regular commission rate will also apply.
11. No item will be removed from the lot before the sale or the day of the sale without permission from the office regardless of whether it sold or not.
12. We at Parker Auctions will try our best to get you the most money we can for your items. If we get close on an item we will sell it. In order to get your item sold, a fair market bid significantly below the reserve will be put on a call bid. Any agreement between the seller and the office staff is binding and overrides all other prior arrangements.
