#### Space Heater Plugs

This quote is to install 18 new receptacles in various office locations throughout the administration building to help address heating-related electrical load issues.

All new receptacles on interior framed walls will be flush-mounted, complete with white devices and plates and a junction box above the top plate to reroute office circuits to the dedicated circuits in the future. In rooms where the walls are concrete, EMT conduit will be surface-mounted along the wall, and a metal 4-square box will be installed above an existing receptacle location. This will allow us to route each dedicated circuit from the attic down to its intended location while minimizing drilling into concrete surfaces.

EMT conduit will be run from the panel located on the mezzanine, through the firewall, and into the administration area. A wire gutter will be installed to allow clean, accessible junctions to transition from EMT to MC cable feeding the new receptacles.

#### Panel Modifications:

The 100A Eaton subpanel currently fed from GE Panel LA will be refed from the main bus bar of the 400A subpanel to ensure it receives adequate amperage capacity for the connected loads. A new 225A main breaker will be installed in the Eaton subpanel to properly protect the panel, as its bus bar is only rated for 225A.
