## ORDER

AN ORDER OF THE COMMISSIONERS' COURT OF HOPKINS COUNTY, TEXAS DESIGNATING AND ADOPTING THE COMMISSIONERS' COURT MEETING SCHEDULE FOR FISCAL YEAR 2025-2026.

WHEREAS, Section 81.005(a) of the Texas Local Government Code provides that the Commissioners' Court by order shall designate a day of the week on which the court shall convene in a regular term each month during the next fiscal year; and

WHEREAS, the Hopkins County Commissioners' Court has considered and designated the **Second and Fourth Tuesday of each month** as regularly scheduled meetings for the Commissioners' Court; and

WHEREAS, the Commissioners Court reserves the right to reschedule any regular meeting hindered by holiday observances or weather-related safety concerns, with such meetings to be held on a date specifically designated and noticed to the public; and


WHEREAS, Special Court sessions may convene as deemed necessary to conduct the business of the County; and

IT IS THEREFORE ORDERED that the Commissioners' Court of Hopkins County hereby adopts the proposed schedule for its meetings.




