



INTERLOCAL AGREEMENT

Hopkins County and Saltillo ISD Road Maintenance

This Interlocal Agreement ("Agreement") is entered into pursuant to the Texas Interlocal Cooperation Act, Chapter 791 of the Texas Government Code, by and between Hopkins County, Texas, acting by and through its Commissioners Court ("County"), and Saltillo Independent School District ("School").

I. AUTHORITY

This Agreement is made under the authority of the Texas Interlocal Cooperation Act, Chapter 791 of the Texas Government Code, which authorizes local governmental entities, including counties and school districts, to contract with one another to perform governmental functions and services.

II. PURPOSE

The purpose of this Agreement is to authorize the County to provide equipment and assistance to Saltillo Independent School District for the repair and/or construction of improvements to a portion of County Road 3534 in order to facilitate safe access to school property.

III. LOCATION

The location of the work to be performed under this Agreement is described as follows:
A section of County Road 3534 beginning at the intersection of FM 900 North and County Road 3534, extending to the west side of Saltillo Independent School District property at coordinates 33.18483 N, 95.32991 W, a distance of approximately 1,023 feet.

IV. SCOPE OF WORK

The County, through Precinct 3, agrees to provide equipment and personnel necessary to:

- Make road repairs
- Construct needed improvements
- Perform other related maintenance necessary for safe roadway access

The specific scope of work shall be determined by mutual agreement of both parties prior to commencement of work.

V. COMPENSATION

Saltillo Independent School District agrees to compensate the County for the use of equipment, materials, and labor at the rate agreed upon by both parties.

Payment shall be made by Saltillo Independent School District within thirty (30) days upon completion of the work performed under this Agreement.

VI. TERM OF AGREEMENT


This Agreement shall become effective upon approval by both governing bodies and shall remain in effect until completion of the work described herein unless terminated by mutual written consent of both parties.

VII. ENTIRE AGREEMENT


This Agreement constitutes the entire agreement between the parties and may be amended only in writing approved by both governing bodies.


